This means that our school provides free meals to all students! This program provides additional support and flexibility for our district to continue serving meals to children while maintaining safety measures and managing the impacts of COVID-19 pandemic.

Included in the impacts of the COVID-19 pandemic are nationwide supply chain and product availability shortages.
